In recent years, the Covid-19 pandemic, de-globalization, geopolitical tensions, economic disruptions, energy predicament, ecological, environmental and climate crises have given rise to and shaped the "polycrisis" currently affecting nearly all nations and has had a profound impact on international politics, the world economy and global governance.
